The **Red Line** will be the system's main line, extending from State Route 26 at Vista del Lago (La Contenta Plaza) to Angels Camp nine times daily, with extension to Columbia College in Tuolumne County six times daily. Buses will run at approximately 90-minute intervals between 5:50 a.m. and 7:20 p.m. Implementing this route was described as a priority in the Short Range Transit Plan.

Zone Change

The **Blue Line** will run between Angels Camp and Arnold five times a day between 5:10 a.m. and 8:00 p.m. It will connect with the Red Line to enable riders to travel to Columbia College or to San Andreas, Valley Springs, etc. An important improvement will enable riders from Arnold and points south on the Highway 4 corridor to connect in San Andreas to the Delta Gold Line for travel to Stockton. The Blue Line will use old Highway 4 instead of the bypass so that the downtown Angels Camp area will be better served by transit.

The **Copper Line** will have five runs daily between Angels Camp and Copperopolis and back. This fixed route has time built in to accommodate requests for transportation to the residential streets off Copper Cove Drive (Feather Drive, Black Creek Drive, Cheyenne Road, Sawmill Road, etc.). Transit will also respond to requests for rides south on Little John Road as far as Moccasin Court to serve residents of Copper Cove Subdivision. This will provide convenient travel opportunities for more passengers. The Copper Line will also have improved connections with the Red Line to enable travel to Columbia College or towards San Andreas.

The **Purple Line** will serve communities currently served by Routes 2 and 3 (Rail Road Flat, Mountain Ranch, San Andreas, Mokelumne Hill, and Jackson). Service to the area has been redesigned to provide more functional transportation options with better connections. The Purple Line will have four daily runs between Mountain Ranch (extended on-demand to Rail Road Flat twice a day) and Jackson Raley's. In addition to providing connection to Amador Transit, this route will serve a group from Calaveras County who daily attend the Community Compass Jackson Day Program. This route will also connect with the Red Line in San Andreas.

The **Green Line** will provide service between West Point and San Andreas via State Route 26. It will be available on Mondays and Wednesdays by request, with a choice of the four departure times shown on the schedule. This route will enable riders to connect to the Red Line on those days. It is anticipated that as people become acquainted with the service, they will plan their excursions and appointments for the two days that transportation is available. Many residents of West Point have indicated that they do not use transit because the current schedule provides only a very early departure and a very late arrival home. With buses leaving West Point four times a day on Mondays and Wednesdays, people will have more options for planning errands or appointments that don't require a long day away from home. Requests will need to be made to customer service by 4 p.m. the previous work day.

The **Yellow Line** will consist of on-demand service available daily for travel from San Andreas at 6:30 p.m. to West Point via State Route 26. This run, currently part of Route 2, is used by Calaveras High School students involved in after-school activities and some commuters. Changing it to an on-demand run will avoid buses unnecessarily traveling the route, such as when school is not in session.

Saturday Hopper Proposed Changes

The Saturday Hopper, which provides travel between Valley Springs and Murphys five times on Saturdays, has been re-designed so that the number of trips to Valley Springs is reduced, but service to Arnold is included. This is in response to many requests from residents in the Arnold area. Impacts of the change on Saturday ridership will provide guidance on how the program should be structured in the next grant cycle. The proposed service change does not increase the Vehicle Service Hours. Also proposed is increasing the base fare from \$2 to \$3, and that the monthly pass be valid for use on Saturdays.
